Privacy notice

As the data controller in terms of applicable data protection laws, the Institute of Maltese Journalists (IGM), a registered voluntary organisation having VO number VO/0211 and with address at Room no. 120 (Third Floor), 280/3 Republic Street, Valletta, Malta is committed to processing your personal data lawfully, fairly and transparently.

The purpose for processing the personal data collected in this form is in order to process your application to become a member of the IGM and, where requested by you, to process your application to become a member of the International Federation of Journalists.

We will not process your personal data for any other reason. The legal basis for processing the personal data collecting in this form is in order to take steps at the request of the data subject prior to entering into a contract.

If you have requested that we process your application to become a member of the International Federation of Journalists (IFJ), an organisation with address at Residence Palace, Rue de la Loi 155, 1040 Brussels, Belgium, we will share your personal data with the IFJ in order to fulfil your request.

We will not share your personal data with any other third parties nor will we transfer it outside the EU without your permission. We will delete your personal from our records once it is no longer required for the purpose stated above, provided that if you terminate your membership with the IGM, we may be required by law to keep some of your personal data for a limited period of time in order to comply with our legal requirements.

If you fail to provide the personal data required in this form, we will not be able to process your membership application and you will not be able to become a member of the IGM and/or the IFJ.

The IGM does not carry out automated decision making. In terms of local and European data protection law, you have the right to access, rectify, erase, object to and restrict processing of your personal data.
